Thank you for the letter received from you today. You have been on my mind and in my prayers. Your letter was an answer to one prayer. Janet has been asking me a question that I can't answer – "Where is Aubree while you are there?" Since you had told me something about Aubree being able to get back in school by the time you get back, I "assumed" she was in the care of Bruce & Sandy. Right?

Things are going well here, We're always busy and always behind. There is simply not enough hours in the day or night. Janet & I will be taking a little trip at the end of this week. I performed a wedding for a couple 50 years ago in Grand Prairie and they want me to return to the scene of the crime and help them recite their vows all over again. It is an honor and I'm glad to do it.

On our way back, we will stop at our daughter's house to pick up her dog for us to "dogset" next week while she takes a friend to be treated at M. D. Anderson Hospital in Houston. Otherwise, she would have had to bring the mutt to us on Monday.

Recardo did the service Sunday afternoon at the halfway house here and was able to baptize two more. He is doing a great job. His father also volunteers and sits at the front desk. He greets folks coming in and helps grade lessons, stuff envelopes, etc. You know what that is like, right?

I will share your letter with Dale about your counselor (Josh Stone) and his potential interest in using the NLB curriculum or CASA there. It's great that they are looking to start some kind of men's group.

I'm glad to hear that you plan to dump the snuff-dipping. I've heard it called another form of thumb-sucking nicotine. In some ways, it is more harmful than smoking (heart attack, dental disease, and cancer of the mouth). Since the inside lining of our lips are blood vessels, the poison has direct access. I have seen more than my share of lips removed in efforts to cut away the cancer. Ugly-looking stuff from snuff. Dale is already talking about picking you up at 8 a.m. on the morning of August 19. Since their daughter and grandson live so near there, and we would need to come the night before, I suggested that he & Karlene use it as another chance to spend a little time with the family. I can always see you back here or in Victoria.

It looks like it's time to sign-off and say 10-4, good buddy. Go, Cowboys!

#### Dear Richard,

This is a short but "personal" note to you following the news you shared with the congregation a few Sundays ago. I appreciate the fact that you felt comfortable enough to come forward and let us know about the state of Diane's health. I can vouch for the facility she is in because we have had others there in the past and Fran Lampton is still there today.

You have been through so much. I had "heard through the grapevine" of Diane's diminishing condition. I know you did all you could for her for as long as possible. Many fail to understand the toll taken on the healthy spouse before reaching this point. I commend you for your love and devotion to Diane. Placing her at Elon is just one more expression of that love. When this kind of thing happens, I'm reminded of God's promise not to give us more than we can bear. I've heard some say they didn't know "how" they would survive. I guess it's not up to us to understand "how" but to know that we *will*. I fear we get too wrapped up in trying to "figure out the HOW" when it's our job simply to still be <u>standing</u> after the storms pass. I think of Ephesians 6 when Paul speaks of our *armor* as Christian soldiers and we are to "after all, **stand**." It doesn't say we won't suffer or not lose a few leaves but after the hurricane is over, *the tree is still standing*.

The Owen family will survive because of your love, your faith, and having each other. You will survive because that's what you do as a Christian family. You do it for each other. You have weathered storms before. By God's grace and power, this is not your "first" test and you're still standing. It doesn't mean all of the pain is gone. It never will but it has caused you to gain strength. I have watched and heard about the kind of man you are for years. I admire your faith and continuing devotion to God.

It is easy to lose our spiritual concentration in this world. It seems to close in and squeeze us. Sometimes I still drive by my parents' old home outside of Victoria or think of my sister and brother and realize I'm the last survivor of the Griffith clan. I drive by the first two homes we lived in here and where we raised our kids. I drive by the old church building at 4420 S. Staples and down the alley to the back door near where my office used to be. I think of Charlie & Mary Ann Dodd, David & Lillian Smith, R. J. & Vivian Whittington, Robert & Charlotte Kirtley, J. D. & Jo Bebout, and so many others who are gone but they left a ton of memories. I was only 34 years old when we came here. In two months, I'll turn 80! Where did the years go? But *one of these days,* we will be together – forever!

I have no alternative but to refocus on reality, today, and right now. God's not through with me. The same is true for YOU. It's OK to be knocked off our feet from time to time. It happens. We are human. In the middle of a storm at sea, Peter temporarily took his eyes off Jesus and started sinking. Then, he "came to" (like from a coma) and cried for the Lord who immediately reached out and caught him. What Jesus did for Peter, He will do for you and me. Thank God!

Kelli comes from an industrious background and we knew she would not be afraid of hard work. Due to her schedule of university classes, her hours were flexible. When Kelli was here, she was here to work.

*Kings Crossing Prison Ministries* supplies correspondence studies to tens of thousands of students. Most students are incarcerated. Much of the grading is done by volunteers. After they finish their work, they bring the paperwork to our office for people like Kelli to follow up on in a timely manner. Delays cause students to lose interest or become discouraged. We knew Kelli possessed both the computer skills needed plus, she works fast. The following are other attributes observed over this time frame:

One other quality we appreciated about Kelli is her kind and generous spirit. Due to the nature of this ministry, employees at times meet clients face-to-face. I hope your mother is doing well in her move back to the DFW area. Of course, we miss her here in Corpus Christi and at Kings Crossing. She was a joy to be around and very helpful in the Lord's work.

We, too, are disappointed that you likely will not be coming here upon release but going back to Arlington or that general vicinity. Still, we must learn to "roll with the punches" and "make the best" of every situation. While there are negative influences there to deal with – those bad influences are in <u>every</u> community. Plus, you know that there are many <u>good</u> and positive influences in the Arlington area. The Richland Hills church (Craig Williams) has several CASA meetings weekly. Dear Jim & Beverly,

I apologize for being SO late getting this letter of gratitude to you for your VERY generous gift of stock/bonds to the Jail/Prison Ministry's *Endowment Fund*. As you know, this is extremely important to our long-term future. I realize that Bro. Kosarek has already provided you with the letter for IRS purposes but I wanted to write and express my *personal* thankfulness!

The *Endowment Fund* will play a crucial role in our current process to find and secure the services of the individual who will ultimately assume my role in the leadership of this good work. I do not know how much Willie has shared with you but we have initiated a five year "transition" plan. As soon as possible, we hope to bring this man on board and start the process of unloading 20% of my load annually. Of course, there' is no guarantee that he will *stick*. He may stay a year and quit. Then, we must start the whole process again. Please, pray for God to bless this important mission field.

Also, I want to apologize that your initial phone call was not answered. On Thursdays and Fridays, John Henry (who normally answers the phone) and I are in prisons most of the day and into the evening. We have so much mail with our 32,000 Bible students that we have to get it to our mail service before 4:30 p.m. or it will not go out until the next day. This necessitates someone leaving the office by about 4:00 p.m. In a recent staff meeting, we assigned one of us to always be *in the office* until 5 p.m., Monday through Friday. Failing to answer such calls should not happen.

We are headed to the 40<sup>th</sup> National Jail/Prison Ministry Workshop at Heritage Christian University in Florence, Alabama (June 12-14). Since all our staff will be there, we will (unfortunately) miss several more important calls. The "answering machine" should record them and we will follow up the following Monday.

Again, thank you for your generosity and faithfulness. A day rarely goes by within thinking of Walter Hicks. I often mention his name when speaking to offenders. He was such a great servant and was deeply loved by so many. Wow! What a legacy.

Dear Tom & Sandy,

Thank you, Sandy, for such a nice note and I certainly do recall your baptism and I also remember when Bro. Peeples was the preacher for the Downtown congregation. Naturally, your parents and mine were members at Central at that time. I always thought Brother Ralph Thomas was one of the most humble men I knew. I did not know

him other than as a young person growing up in the congregation but I loved his mild and quiet spirit. If you knew my Dad, he was much the same way – not one to make a big "splash" or be seen or heard much.

I was 21 years old when you were baptized in 1964. Wow! It seems like yesterday, doesn't it? I am glad that you have remained strong in the Lord all these years. I am in Florida a few times each year and one time I visited on a Sunday morning in San Jose (Calvin Warpula was the preacher at the time). I think my return flight was from some airport nearby. I've also preached in St. Petersburg but in conjunction with a prison ministry workshop being hosted by the 20<sup>th</sup> Street congregation. More recently I was in Tampa for a similar event. I love Florida and the St. Pete area reminds me a lot of Corpus Christi.

I married Janet (Ellis) on August 14, 1964. She & I were both born in Corpus Christi and actually attended the First Grade together (but did not know each other). We met during a VBS at Central in the summer of 1961 and went to ACU together. Her sister and brother-in-law (Norman & Marlene Glasson) were members at Central. Upon graduation from ACU, we moved to preach for 3 years in two rural congregations near Lubbock. In 1969, we moved to Grand Prairie where I preached for 8 years at the Burbank Gardens congregation. It was while there that I first visited a man in Dallas County Jail. I ended up baptizing him and he introduced me to others and I have not been able to stop ever since.

We moved to Corpus Christi in 1977 and I preached for this congregation for the next 25 years. All the while, I was getting more and more involved in the jail and prison ministry, aftercare and substance abuse recovery. So, two years before my 25<sup>th</sup> anniversary as the "pulpit guy" – I told the elders to be looking for my replacement because, Lord Willing, I will do prison work for the rest of my life. I have never regretted it. This is the most rewarding work I have ever done in all my efforts to serve our Lord.

I love to see people change the way they live. I am attracted to seeing the drastic way offenders (and addicts) change their everyday lives. At the same time, I am *discouraged* when I see members of the local congregation who seldom change. I have "preached my heart out" from the pulpit only to see minimal change in people's lives. In fact, most brethren often appear "insulted" when they hear me exhorting them to change. I would be satisfied if I could just get them to *cuss* a little less and *show up* at church meetings a little more. Most offenders (and addicts) know – without a doubt – that they *need* to change and more importantly, they desperately *want* to change.

Ed Brown (the preacher at Central when I was a teen growing up) really inspired me. He was <u>so</u> dedicated. I watched Ed preach and sometimes his face turned so red I thought he was going to have a heart attack and die right there in the pulpit. I saw tears come from his eyes while hoping someone would respond during the invitation song. When I went off to Abilene, I did not "intend" on becoming a "preacher" – I went there to play football, enjoy myself, earn an Art degree, land a high-paying job as a commercial artist, and live "The Good Life." Ha! The Lord has a way of turning us completely around, doesn't He? ACU's Art Department at the time was into "Modern Art" (it looked like someone threw some paint on a canvas, stood back and named it something crazy. Obviously, that was not my idea of art. When I got serious about serving the Lord, I wanted everyone else to get serious – starting with my football team. Well, most of them didn't "want" to change either.

Still, something about a "challenge" has always been attractive to me. It is a challenge to try to change college-level athletes. In each place where I preached after getting out of Abilene, I was always drawn to husbands who would not come to church, thought they had to be "macho", drank, smoked, cussed, etc. So, when I went into the Dallas County Jail, I was attracted to trying to encourage men to change (whose lives were a total disaster). And, strangely enough, I found many who genuinely wanted to change.

I work on the principle that "I cannot care more than *you* do." As long as I see a person willing to change, I stick with him and bend over backwards to help. When I see him slacking off or turning away, I have no option but to do the same and turn my attention to the <u>next</u> person I find who is serious about change.

Well, I didn't mean to go on and on and on ... I apologize.

Again, thank you for writing and may God richly bless your lives in His service. I hope to see you again some day.

Dear Brethren,

First, I want to express my gratitude for the invitation to speak there on the prison ministry effort on Sunday, April 10<sup>th</sup>. I had wanted to do this for a long time. My purpose was not to ask for *money*. I wanted to provide information for members to contact us when learning of one

incarcerated or struggling with addictions. Please call us if and when you are aware of such. Since returning to Corpus Christi in 1977, it has been a privilege to minister to many family members and friends of Christians throughout South Texas as well as many other cities and states.

Second, I want to express sadness at seeing the Ayers Street property sold and the Lord's work there coming to an end. As you know, I was baptized at Ayers when we worshipped at North Beach in the 50's. Several members from Ayers assisted with that work. Thus, I am aware of the variety of emotions you must be experiencing as you face the final business matters before you now. Hopefully, there will be a spiritual pride and sense of relief once you complete these tasks.

Finally, it was suggested that I submit to you – in writing – some of our pressing "needs" in the prison ministry. I am glad to do so. Let me begin by briefly defining the difference between **NewLife Behavior Ministries (NLB)** and *Windsor Park Prison Ministries*.

## The needs I present are on behalf of *Windsor Park Prison Ministries* which is under the oversight of the elders at Windsor Park Church of Christ.

NLB is a separate 501 (3) (c) non-profit, tax-exempt organization formed in Dallas in 1984 and operates under a board of trustees. NLB is a "curriculum-based ministry" meaning that it develops life-changing curriculum primarily for prison ministry use - worldwide. It has no paid employees. Since NLB asked me to become its President in 2002, we closed the Dallas office and combined it with that of *Windsor Park Prison Ministries* to cut expenses and utilize whatever leadership ability I possess. The available staff of *Windsor Park Prison Ministries* is "icing" on the cake.

Under the oversight of the elders at Windsor Park Church of Christ, funds contributed to *Windsor Park Prison Ministries* are accounted for by the elders. I cannot sign on the bank account and all expenditures paid require receipts. Checks are signed by two elders. We supply quarterly and annual financial reports to donors. We firmly believe donors have a right to know exactly how funds are used. We can receive direct transfers of stock and other material assets (land, homes, vehicles). We occasionally receive proceeds from wills/estates of individual Christians. *We do not accept any government funding*. We believe this to be the work of the <u>church</u> and thus, of Christians rather than the *world*.

Although there are a multitude of aspects to *Windsor Park Prison Ministries* (<u>Christians Against</u> <u>Substance Abuse-CASA</u>, *Baptistries Around the World*, Follow-Up on Ex-Offenders, *FamilyNet*, Little Angels, etc.), I will highlight our most pressing needs.

- \$150,000-\$200,000 My highest priority is to find the right man to join us as soon as possible to begin on-the-job-training as my eventual replacement. This is not part of our budget. This individual will need counseling, writing, organizational and managerial skills. He must be a gifted teacher and public speaker. Fund-raising ability is essential. We want a person between the ages of 30-40 to spend the rest of his life growing with this ever-expanding ministry. I will remain active for at least 8-10 more years so duties can be shifted gradually over time. This is the largest prison ministry in our brotherhood and it is critical that we take steps to insure its continuity and effectiveness. We have other needs but none is more important than this. These funds will allow the right person to come in and systematically replace these funds, sustaining his future salary.
- **\$25,000-\$30,000** We need to replace our 1997 Dodge Caravan that is used almost daily in going back and forth to prisons (current mileage: 120,000). Every

Sunday and Monday we drive 360 miles (roundtrip) to the Three Rivers prison. Periodically we drive to the Lopez State Jail in Edinburg on Wednesdays (160 miles roundtrip). Thursdays, we make <u>two</u> roundtrips to two Beeville prisons (280 miles roundtrip). We go to the Glossbrenner Unit at San Diego on Fridays (110 miles roundtrip). We visit three different county jails and a juvenile detention center. Fifteen weekends are spent in "Gospel Meetings" inside various prisons in and outside of Texas annually.

- **\$25,000** We want to add a person to our staff upon completion of the licensing procedure this summer, becoming a Licensed Chemical Dependency Counselor (LCDC). This individual is a fantastic teacher and we need him to provide leadership to our CASA program. With this addition, we will be able to touch many more lives as an intensive out-patient alcohol and drug treatment program. And, he will remove a huge load from my back.
- **\$25,000** We spent \$40,000 in 2004 to place permanent and portable baptisteries in jails, prisons and church buildings throughout the United States and foreign countries. This was seriously under-funded by donations . . . to the tune of about \$25,000. Unless these funds come in, we must reduce the number placed in 2005.
- **\$12,000** We need to purchase a minimum of 2,000 "Serenity" Bibles in 2005. These are used with our CASA program graduates in prisons. The 12 Steps are highlighted in the Bible, addressing each "step" in the recovery process. Through a special arrangement with the Nashville publisher, we can purchase these at 50% below their retail cost but they must be purchased all at one time.

I could go on but I hope this gives you sufficient information to decide what you want to do. If you have any questions, please do not hesitate to call. I have been ministering in prisons for 34 years and I believe I know how to do it. Still, *I learn more every day*. Since I am in and out of prison (and out-of-town, also), you can reach me best on my cell phone (361-947-5494).

Again, thank you for your thoughtful and prayerful deliberations and decisions.

Dear Friends,

I'm sitting in Jacksonville International Airport (Florida) waiting to fly home. Prior to leaving Corpus Christi, I prepared the enclosed sheet but wanted to send a letter with it. So, I'm trying collect my thoughts in spite of the past several very busy days. Let me share a little of what has been going on . . .

Our *Reconciled & Renewed Seminar* "team" (Pat & Glenda Watson, Karen Jones, Joan Bruster, Pam Zapalac, John Henry Pruitt & I) conducted a Saturday event at the women's facility in Lockhart, Texas on February 12. It went very well and the Chaplain now wants us to come to the same at the men's unit.

The next morning Bob & Maggie Wachtel, John Henry & I went up to Vanderbilt. They are an evangelistic group, supporting many good works – one of which is this ministry. Bob taught the Bible class, I preached, we enjoyed a great meal, and John Henry spoke to the after-dinner crowd. John Henry & I stayed to teach both the male and female inmates at the Jackson County Jail in Edna, Texas that evening.

I left February 17 (by car) for an in-prison seminar at two federal facilities in Forrest City, Arkansas. I had been at two *state* prisons in Memphis (Tennessee) two weeks earlier. I took my car and left early for Forrest City because I needed to contact area volunteers to follow up with *NewLife Behavior* courses. I did so and met with all four briefly after the Sunday morning service. The new Chaplain at Forrest City is begging to have NLB offered to residents there. Pray that this will soon be a reality.

It was a privilege for me to speak three times to the men in the two federal units (my participation in these events is in cooperation with *Federal Outreach Prison Ministry* out of Nashville). The weekend ended with 5 baptisms, 3 rededications, and about 50 enrolled in Bible correspondence courses! The Chaplain is already trying to schedule us to return. A strange thing happened at Forrest City. Many of you remember our much-loved prison ministry secretary that we lost to cancer several years ago – Sharon Wanzer. One of her sons, Mark, is a corrections officer. I saw him over the Christmas holidays and he told me he was transferring from California to a new prison. Well, as we were going into the prison on Friday night, Mark Wanzer was leaving for the day! It was great to see him and he sends his love to all!

After the Sunday afternoon baptisms on February 20, I headed for Abilene and reached Grand Prairie a little past midnight. I enjoyed breakfast the next morning with James Curry (one of our newest NLB board members) before hitting the road, arriving in Abilene in the early afternoon. Bob & Maggie Wachtel had graciously carried our display up to the ACU Lectures on Saturday and had everything set up by the time I got there. Two prison ministry classes were offered this year: Bill Crossman (Leavenworth, Kansas) and James Freies (Lancaster, California). Prison ministry workers enjoyed a noon meal on

Tuesday at University Church of Christ. I met some that I had not known previously. We hope to make this an annual gathering.

Bob & Maggie brought the display back on Thursday but I got home in time for the CASA class on Wednesday, February 23. The next few days were spent getting ready to host the statewide "Winner's Circle" conference at the Bayfront Inn, Saturday, February 26. "Winner's Circle" is affiliated with A.A. and our local "Sparkling City" group is sponsored by CASA. Rick Cantu is our *main man* locally. Rick and Jerry Hinkes did most of the work in pulling this event off successfully.

The Arlington Height congregation (another of our supporters) is between preachers. They asked me to "fill in" on Sunday, February 27. I said "yes" on the condition that I would be able to give them a report on the prison ministry. Between the morning and evening services, I ran up to Three Rivers to preach at the Federal Prison Camp.

Monday, February 28, I signed a 3-year lease on our office that includes more space down the hall for group meetings and a small office for myself. We have been putting this off for a long time. The space became available and someone else was going to snatch it up. They are doing some painting and remodeling in the new space at this time. We can begin using it April 1.

Things got busier the next few days. Jerry Stephenson wanted me to speak at a Prison Ministry & Alcohol/Drug Conference this last weekend at Midwest Church of Christ in Louisville (Kentucky) but I had already committed to speak at Florida's statewide meeting at University City Church of Christ in Gainesville. So, John Henry went to Louisville and I went to Gainesville. Each of us took a load of sample materials. John Henry & I ran into each other making airline connections in Houston on our way home late tonight. We feel our time was well spent. Brother Stephenson is the preacher and an elder at Midwest and he now needs our display and more materials to take to Nashville for the National Conference of Black Ministers on March 15.

Early in the morning, I'll make copies of this letter and get it in the mail to you. Thank you so much for your prayers and financial support. The enclosed sheet gives you an idea of the information we need to get out to be more effective in 2005. as mentioned in our year-end report, we suffered our great loss in 2004 in a drop of support from <u>outside</u> of Texas. We must close this gap and much of the answer involves communicating the facts. Thank you for helping us *spread the word*!

Dear Mr. Cavazos,

Thank you for taking our Bible studies by mail, doing so well with them, and enrolling others. The religious education materials requested will be sent. However, I will not send anything, at this time, to the Chaplain you mentioned in your letter. Let me explain why and, hopefully, you will pray about it and agree.

Please begin with the concept that people actually "believe" what they say they believe – right or wrong. Saul of Tarsus persecuted Christians and the church with a conscience that was absolutely clean. The other option is to think others deliberately teach error – knowing that it IS error that they teach. I know many ministers that sincerely do not believe that immersion in

water is necessary. But while they do not teach or practice baptism as we do, they will not stand in the way of others practicing *their* faith. We must allow chaplains a right to their personal beliefs just as we want our own to be allowed.

You (as an offender) nor I (as a free-world volunteer) are not in a position to change the beliefs of chaplains. Hopefully, at best, we can have their cooperation and permission to send religious teaching materials into institutions such as Gist. Doing so, recipients (like chaplains) can choose what to believe. On the other hand, chaplains have the authority – backed by wardens, assistant wardens and other staff – to deny our teaching materials to even enter the Unit.

Third, you may elect to contact *another* chaplain (unless the one you mention is the only chaplain there). The majority of chaplains that I know are excellent in trying to accommodate offenders' beliefs. They must allow a variety of practices that go *against* their personal beliefs in doing so (such as special diets, holy days and celebrations, etc.). In their position, these allowances are necessary. When an offender starts pushing for additional items, the chaplain may be tempted to throw up his hands and quit!

The additional items I am referring to are things like acapella singing, full Sunday services with the Lord's Supper every Sunday (with unleavened bread and the fruit of the vine), etc. At some prisons, ALL these are permitted while NONE are allowed at others. It all begins with a request from an offender but the request must be made "in meekness and fear" rather than in a *demanding* way.

I hope these thoughts will be helpful in days ahead. Also, I am not suggesting that your belief is "wrong" in any way. I pray daily for patience, wisdom, and understanding. May God bless you in your continuing study of His Word.

Thanks for writing. I got your hand-written note one day and your type-written letter the next day! Guess which one was the easiest to read? Smile . . .

No, I'm not doing the preaching any more and I am really enjoying the fulltime work in Prison Ministry and <u>Christians Against Substance Abuse</u> (CASA) and NewLife Behavior Ministries. Of course, it keeps me busy and off the streets – Ha!

Our new pulpit guy is Mark Pugh. He came to us about 2 years ago from Shreveport. He is about 10 years younger than I am, three children (all grown and out of the house), and a wife who is a schoolteacher. He really loves preaching and he has been SO good for Windsor Park. We have grown and will start on our new building this August. We have bought about 11 acres off Staples & Yorktown – close to the Kings Crossing subdivision. It will be called "Kings Crossings Church of Christ" and will have a parenthesis under the name for 5 years that says ("Formerly Windsor Park Church of Christ").

I apologize for being so long in responding to your letter of September 1 telling of your opportunity and desire to begin a new work in the state prisons of Texas. This is exciting news! Of course, I regret the loss of your position as a TDCJ chaplain but pray this transition will open even *more* doors.

Please send me one of your "information packets" because I want to get to know you much better. I salute the Court Drive congregation in Palestine for their willingness to oversee and sponsor your work. Yes, you are strategically located to do enormous good in multiple prisons of that area. As a volunteer, you will be able to minister to a multitude of offenders rather than tied to an *assigned unit*.

Have we ever met? I thought I personally knew all the Texas chaplains affiliated with churches of Christ but your name does not "ring a bell". My questions are probably all answered in your packet but I wonder . . . how long you have served as a TDCJ chaplain, at what units, your educational background, training, other church-related activities, "home" congregation, wife, children, age, etc. Have you done any work with those inside the Rusk facility?

And, I don't believe that you are included in the *National Directory of Churches of Christ & Individual Christians Involved in Jail/Prison Ministries.* If you would like, I'll be glad to add you. One of the positive results of your letter is the improved "networking" as fellow prison workers

seek help via referrals (this is the purpose of the "National Directory"). Others need to know about you, too.

I applaud your efforts and want to encourage you in every way possible. I am sure you are well aware of how difficult fund-raising for this ministry is – especially outside our primary circle of influence. I imagine the bulk of your support will come from Court Drive and congregations in your immediate vicinity.

Windsor Park Prison Ministries has been going strong since 1977 (I began in Dallas County in 1971) and it is still a huge struggle to keep our heads above water financially. I'm sure the same can be said for others working full-time in this field in Amarillo, Lubbock, Abilene, Wichita Falls, Dallas/Fort Worth, Huntsville, Houston, Sugar Land, Texas City, Austin, Palestine (I assume you know Dale Arnett and Bill Brewer), etc., plus dozens of others ministering on a part-time basis. Since this ministry began in 1991 we have been blessed to place 164 permanent and portable baptistries in 28 different states (including 49 in foreign countries). Thus far, 123 congregations in 29 states have participated in various degrees in making this possible.

Rarely does a week go by without receiving a call from some congregation or a prison seeking information and help in getting a baptistry for prison, domestic or foreign use. We would love to say "Yes" to every request but, of course, we are limited by the amount of funds available.

While we seek help from other states when requests come in, we normally are looking for help to place at least two or three in TEXAS jails and prisons <u>every</u> year! Dear Friends:

As each year winds down and a new one is on the horizon, we extend an invitation to everyone we can to make financial gifts to the Prison Ministry. It just so happens that *tax*-wise, this is a good time for many. Duplications *will* occur. This means that some recipients may have <u>already</u> given and are "regular" donors (if so, we regret the duplication and say "Thank You" for your generosity). In the interest of time and with limited secretarial help, we are unable to "personalize" each letter. Some of you may not know much about this ministry and thus, we hope to share valuable information with you. We are confident that many will eagerly accept an opportunity to "visit those in prison" through this ministry with a contribution.

#### So . . . what is this ministry really about?

Obviously, we go directly behind bars taking the Gospel to prisoners in juvenile facilities, county jails, and state and federal prisons. If interested, we can supply you with the names and locations of specific institutions, days and times of services, etc. We also conduct weekly classes at the Parole Board. We work with probationers in fulfilling community service requirements. We minister to inmate family members and frequently counsel crime victims. Through our Bible Correspondence School we distribute about 75,000 Bible lessons, 50,000 tracts, and 5,000 Bibles each year with 400-500 or more requesting to put Christ on in baptism!

Speaking of baptisms, since 1991 when we began the **Baptistries Around the World** effort, we have placed approximately 150 baptistries inside jails and prisons. Plus, many have gone to missionaries in foreign fields. We "project" placing 6-8 baptistries annually but pleas come from prisons where taught souls are patiently waiting to be baptized (some have been waiting over a year) and it is difficult to turn them down. So, at the end of each year we try to "make up" the budget deficit in this category (which now stands at \$7,237.76). It seems that ALL of us ought to enthusiastically support efforts to immerse believers into Christ. We're talking about people who have already been taught, they believe, they have repented, and they are crying to confess Christ as God's Son and be baptized. We need help.

In 1983 we began the *Christian Training School for Ex-Offenders*. What good is it if we immerse millions behind bars if there is no follow-up when released? About 50 ex-offenders from 12 states went through our residential program. In 1993 we ceased the residential aspect of the program and started focusing on helping local congregations to do follow-up effectively in their own communities. It was quickly apparent to us that we could not receive in Corpus Christi, Texas - ALL Christians being released from prisons all over America. However, we *can* (and do) help many but through networking and training others, we assist far more!

<u>Christians Against Substance Abuse</u> was begun in 1988 and has proved highly successful in encouraging recovery from addictions of all kind (especially those in the grip of alcohol or other drugs). Today, this program is licensed by the State of Texas and exists both in free-world communities as well as behind bars. Many Christian families are hurting because of addiction. A number are sent here for treatment but we cannot fully underwrite the cost. We do not operate a *residential* program but offer extensive out-patient treatment (and local private-pay detox facilities can be utilized). A few families are able to assist to a degree but we need more help. We do not "win" them all. In fact, we worked for years with the only son of a blind widow but with minimal success. He died at an early age last year. A few months later his mom died and left her small estate to the prison ministry. Before she died, she said she realized that we could not help her son without his cooperation but perhaps through her assets, we would be able to help someone else's son!

This work operates under the oversight of the six elders at Windsor Park: Ron Cardwell, Bob Hughes, Jack North, John Poynter, Larry Reynolds and Jimmie Russell. It is my honor to serve as "Director" of this exciting mission effort and P.J. (Pinky) Bates is our full-time *prison missionary*. At this time, we are financially unable to have a full-time secretary and due to local ordinances, we have had to bear the expense of an office away from the church building (to preserve our Christian education program there). Ex-offenders cannot be on the same site with minors. Unfortunately, this adds up to an added \$10,000 a year expenditure which *wrecked* our "regular" prison ministry budget. By paying for a year in advance, we get one month *free* and the lease runs out at the end of March, 2000.

As of last year, we added a line item to the budget for "Follow-up with Ex-Offenders" and this allows donors to assist individual ex-offenders as needs arise. As you can imagine, many such needs surface throughout the year. Often, these are "start up" costs as an ex-offender gets a place to stay, utility deposits, food, tools/special clothing for a new job, etc. One such *ongoing* need concerns John Henry Pruitt. Many of you already know this 71-year-old brother and the tremendous help he has been in this work. Since John Henry spent 37+ years behind bars, he enjoys almost no Social Security benefits. He works mornings at the City Hall for minimum wage, but we don't know how long that will last. When unemployed, his Section VIII rent was \$47 per month (all bills paid). When he went to work at City Hall, the rent jumped to \$277 per month! It appears that our nation penalizes those who work but John Henry is a proud man and

wants to do what he can to pay his own way. But who wants to employ a 71-year-old black man with a criminal record longer than your arm?

In the afternoons, he comes to the prison ministry office and assists us there. John Henry also goes into juvenile centers, jails, prisons, facilitates CASA groups, and teaches in training seminars to prepare free-world volunteers for effective service in this mission field. We cannot afford to add him to our paid "staff" but we are hoping there is sufficient interest among those receiving this letter that contributions will be sent and ear-marked "for John Henry."

All donors receive our monthly publication, *Walking In the Light*, and quarterly financial statements so you can keep up with all that is going on. May God move you to take advantage of this opportunity to donate to this productive mission field. More than anything, we covet your prayers. Our God meets ALL our needs!

Dear Walt,

First, I want to acknowledge – with grateful appreciation – the \$1,000 gift (check #170 dated November 9, 2003) to Windsor Park Prison Ministries! It was quite a surprise. It also arrived at a "perfect" time since we end each year with a special effort to raise funds and start the New Year in positive shape – fiscally.

I fondly remember Sy and Evelyn Allen. They visited us in Corpus Christi on more than one occasion and they heavily supported us financially until their health deteriorated and, of course, death overtook them. I was touched but not surprised when I first learned of their generosity toward the prison ministry in their wills. Still, with the proper staff and supervision, the challenge you brethren have as stewards is huge. I will be glad to visit with you (as mentioned at the end of your letter) about this at your convenience. I am often in Dallas and will be glad to meet with you (and any others interested) to discuss this matter at length.

I understand that the \$1,000 gift may be a "one-time" thing but we would be glad to enter into a partnership with you on a long-term basis, if possible. Allow me to share highlights of this mission field by sharing a little concerning the major areas of emphasis.

Through **Baptistries Around the World** we place baptistries (permanent <u>and portable</u>) in jails and prisons throughout the United States. We began this effort in 1991. Several go overseas to missionaries. Naturally, the number of baptistries placed depends upon the funds contributed for this purpose. To date, we have placed about 200 baptistries. We know of souls now waiting for a baptistry in order to put Christ "on" in obedience to God's Will. It is hard for us to say "no" when a prison chaplain asks for a baptistry. In fact, we often say "yes" and then get ourselves into a bind trying to raise the necessary funds for it.

*CASA* (Christians Against Substance Abuse) began here in 1988 and has now spread nationwide and even to several foreign countries. If you are familiar with *NewLife Behavior Ministries*, CASA is Course VIII in that curriculum. This Christian 12-Step recovery program is in many jails and prisons as well as an outreach ministry in local communities. It is licensed as a faith-based treatment program by Texas Commission on Alcohol & Drug Abuse. It has the official approval of the Chaplaincy Division within Texas Department of Criminal Justice for use in all state prisons. We are finding more and more church members and families struggling with addictions. CASA exists to offer education, guidance, and encouragement.

*Christian Training School for Ex-Offenders* (CTS) was begun in 1983. We realized that many prisoners were being baptized but they were being "dropped" upon release. For 10 years we operated a "residential" aftercare facility and learned tremendous lessons about this important phase of prison ministry. We have ministered to a total of about 100 ex-offenders from at least 13 different states thus far. We no longer operate a residential facility because we do not see it as effective as one-on-one aftercare. We expect our next ex-offender to arrive on February 7. Untold numbers of other ex-offenders have been assisted as a result of helping *sister* congregations that have set up similar aftercare programs.

Of course, we remain extremely active <u>inside</u> jails and prisons across America. I participate in at least three in-prison seminars annually (Phoenix, Arizona, Marianna, Florida and Memphis, Tennessee) with the National Federal Prison Outreach Ministry headed by Ron Goodman in Nashville. Our large Bible Correspondence School reaches thousands annually with a student body of about 6000. We maintain a *National Directory of Churches of Christ & Individuals Involved in Jail/Prison Ministries*. This is a valuable tool if we are to effectively follow-up on exoffenders and family members of the incarcerated. We also maintain a list of local contacts for follow-up in every state and federal facility in Texas.

Here is a capsule report on the first eleven months of 2003.

Baptism Requests: 588	Prayer Requests: 534	
Bible Lessons Distributed: 97,977	Tracts Distributed: 78,286	
Bibles Distributed: 8,341	Total Students: 5,689	

Three years ago we started our "Little Angels" ministry. This is an effort to show the love that churches of Christ have for small children who are adversely affected by the criminal justice system. They did not commit any crimes so we refer to them as "Little Angels" (knowing how precious children are to Jesus). Depending on funds available, we purchase \$25 Wal-Mart Gift Certificates for the children. While we make a special push in November and December, this is not just a "Christmas" time project. We find children in need all year long. Most do not need toys but they need shoes, socks, underwear, and sometimes – medical or dental attention. Some friends contribute especially to this need every year and it is deeply appreciated.

Due to difficulties associated with having a lot of ex-offenders at the Windsor Park church building, the Prison Ministry was forced to lease office space at a commercial location (3833 S. Staples, Suite 10), just down the street from the church building. While this significantly increased our expenses, it also has opened many doors. People pass by and see the signs on our windows and come in to "check us out". I am convinced that most of these would never have stopped on Windsor Park's parking lot and entered the church building to "check us out". This reminds us on Romans 8:28 and how things work out for good!

We are excited about 2004 and *beyond!* We are looking for brethren who will join hands with us (perhaps in monthly support or once-a-year gifts to help with a particular project such as *Baptistries Across America* or CASA or CTS or "Little Angels" or . . .

On behalf of thousands of lost men and women locked up (along with their *families*), I want to thank you for any consideration you might give these efforts. If you have specific questions you would like answers to, feel free to ask. This ministry is under the direct supervision of the elders, Windsor Park Church of Christ. Quarterly financial statements are provided all donors.

May God richly bless you and all your efforts to glorify Him in 2004. I look forward to hearing from you again soon.

Dear Chaplain Mantooth:

We appreciate your encouragement of the residents there and outside volunteers like our mutual friend, Wayne Rutland. Wayne has wanted our co-worker, John Henry Pruitt, to go into Kenedy as well speak to his local congregation as soon as Mr. Pruitt became an "approved volunteer" and was added to the TDCJ computer system. This has now been done, as you know.

Wayne recently called Mr. Pruitt to invite him. But, I told Mr. Pruitt to have Wayne pre-approved his coming into your facility. At Beeville, authorities need at least two weeks "advance" notice before bringing someone "new" in, even though they are on the computer. I suppose that Wayne checked with you because he asked me last night to send you a letter introducing Mr. Pruitt and give you my personal recommendation. I am glad to do so.

Mr. Pruitt was incarcerated over 37 years. He became a Christian at Huntsville's Wynne Unit where I first met him in 1984. We made plans for him to come here for training when released. He arrived at the Kerper House (a halfway facility no longer operating) in 1992 and Mr. Pruitt has worked with us faithfully ever since. He is now about 73 years old, in good health and a recovering alcoholic-drug addict. He is a fairly large black man, outgoing and friendly.

Mr. Pruitt is a tremendous help in CASA (<u>Christians Against Substance Abuse</u>). While still at Wynne, he helped Dr. Hillery Motsinger design the first NewLife Behavior course, *A Sense of Self.* Also, he has written a tract, *What <u>Keeps</u> Me Free?* He works mornings (Monday-Friday) in the Engineering Department at the City Hall. In the afternoons he works at the Prison Ministry/CASA Office. He has been a Bible teacher in Nueces County Jail and Nueces County Juvenile Detention Center for years. He frequently speaks to church youth groups, schools, and at prison ministry workshops and seminars. I assign Mr. Pruitt to attend and man our Prison Ministry booth at various gatherings around the country from time to time.

Mr. Pruitt has been able to enter a number of different state and federal units on a "one time" basis prior to becoming a *TDCJ approved volunteer* (Hackberry Unit, Gatesville and the Federal Medical Facility, Fort Worth). We are fully incorporating Mr. Pruitt into weekly CASA programs at Lopez (Edinburg) and Garza West (Beeville) just as he already has been in Nueces County facilities. Thank you in advance for your assistance in this matter. If you need more data, let me know.

I regret that you have Hepatitis C. Lots of my closest friends have it, too. You just learn to live with it (like folks have to do with diabetes and lots of other diseases). Knowing you have it, however, can help you understand better some of the things your body and mind experiences from time to time. At least, you know that you're not going nuts! Smile . . .

I had to go back to Grand Prairie twice recently. Once for a funeral (Rufus Sabedra used to be a deacon at Burbank Gardens about 100 years ago). Another time for the National NLB/CASA Conference at Turnpike and it was awesome – over 200 attended. I'm anxious for the day when you get out and can attend with us and speak and sing and rejoice in the Lord!

Also, regret that you feel like a "number" in the setting there. It can be a humbling experience but working through it builds us up. If we give in to it, of course, we just get weaker and stay weaker. I know you will battle through it with God's help. Others there need you and I am confident that you are finding ways to reach out and share the love of Jesus.

I've got to go to Phoenix on Thursday and participate in a weekend seminar at two federal prisons there. I go along with a group from Madison, Tennessee about 3 times a year. Keep me in your prayers. I had a place cut off my belly a few months ago that turned out to be cancer so they sent me to M.D. Anderson for some more surgery.
